THE FUTURE OF RESEARCH, INNOVATION AND OUTREACH AT KCA UNIVERSITY

Question 1:

The KCA University Strategic and Vision Plan 2019-2023 identifies Research, Innovation and Outreach (RIO) as one of the key pillars of the University. How has the university ensured that RIO flourishes?

Answer:

There has been exemplary performance by both faculty and students in the various areas of Research, Innovation and Outreach. This has been made possible by putting in place a conducive environment backed by policies, strategies and initiatives that support Research, Innovation and Outreach (RIO). I am pleased to report that the University recently established a Division of Research, Innovation and Outreach to help catalyze RIO at KCA University and position KCA University as an institution that is committed to research excellence. Our faculty and students are currently implementing various innovative projects including in the areas of technology, business, health, entrepreneurship, economics, creative economy among others.

Ouestion 2:

Kenya's Vision 2030 provides a roadmap for transforming Kenya. How has research at KCA University contributed to Kenya's vision 2030 and the Big Four Agenda so far?

Answer:

The overarching goal of Kenya Vision 2030 is to transform Kenya into a newly-industrializing, middle income country providing a high quality of life to all its citizens in a clean and secure environment. The higher learning institutions had to align their priorities with the Vision 2030. Our approach to research is guided by the vision's pillars because the nation must make deliberate choices supported by data from studies and other forms of proof. In addition, KCA University has produced over 40% of all accountants in Kenya who have held and or continue to hold various positions of leadership and hence impacting society.

Question 3:

Sourcing for Research Grants has become globally challenging. How is KCA University responding to this challenge?

Answer:

Kenya has witnessed tremendous growth in the number of public and private universities. This has resulted in demand for qualified faculty to teach and supervise the increasing number of students at undergraduate and postgraduate levels. Consequently, stiff competition for research grants to support postgraduate students and for the generation of new knowledge has ensued. This trend has been witnessed globally. With increased population targeting the same donors, it is evident that competition will continue. To respond to this, KCA University has strategically entered into partnerships and collaboration with leading learning and research institutions across the globe. These collaborations have bolstered our chances of attracting research funding. We have also created specialized centers and directorates domiciled in the Division of Research, Innovation and Outreach to spearhead our resource mobilization activities and strategies. These directorates have been instrumental in training our faculty members on techniques of writing competitive grant proposals and formation of multi-institutional multi-sectoral research collaborations.

Question 4:

Research Ethics and Safety is an important global issue. How is KCA University ensuring research ethics meet international standards?

Answer:

Research is specifically the process of establishing facts or reaching new conclusions. These facts and new conclusions are realized in different disciplines including, business, technology, health, humanities, engineering, natural sciences, education among others. Further, establishing these facts or reaching new conclusions involve participation of humans and animals; commonly known as the subjects. To ensure that such a process follows the acceptable international standards, KCA University has established an Institutional Ethics Review Committee (IERC). This is one of the specialized Units in the Division of Research, Innovation and Outreach. The Committee ensures that all undergraduate, postgraduate and donor funded research activities emanating from KCA University comply with the national and international allowable research ethical considerations. The committee is also NACOSTI accredited and vets research proposals from other institutions to ensure safety of the participants and research subjects.

Question 5:

What is your niche as a research institution?

Answer:

Over the years, KCA University has been associated with the training of CPAs. In fact, records show that over 40% of all CPA in Kenya are trained at KCA University. As a higher learning institution, we are proud of this recognition. As the demands for higher education in different fields continue to grow, the university has significantly invested in business and economics, technology, humanities and social science and creative performing arts. Just as we have carved a niche in the training of CPAs, we are considering introducing other market driven courses.

Ouestion 6:

How is the Vice-Chancellor and CEO's research and innovation fund supporting budding researchers?

Answer:

The Vice-Chancellor and CEO's research and innovation fund has been instrumental in providing modest funds for early career researchers and students to venture into research and innovation. Through the initiative, early career researchers and students are introduced into the competitive world of grant writing and the reviewing process. The reviewers' comments are shared with both the successful and unsuccessful applicants for necessary improvements. With such contributions from experienced reviewers, the applicants get training in writing winning research proposals. This fund is the first of its kind to be established by a University in Kenya.

Ouestion 7:

What are the next steps for KCA University in terms of research roadmap?

Answer:

With the increasing paucity of resources, there is a need for institutions of higher learning to invest in the incubation and commercialization of research outputs either through licensing or creation of new ventures. KCA University is keen on creating wealth through commercialization of research outputs. This is our next big agenda as a university. That is why we have embarked on establishing research, innovation, and incubation hubs in all our campuses.

Question 1:

As you are aware, the core mandate of KCA University is teaching, research and technology transfer. As a Division, we are committed and driven by the University Vision and Mission statements to ensure an optimum environment and ecosystem which encourages and promotes excellence in research, scholarship and innovative endeavors. Question 2:

These specialized Directorates and Units have proved vital in resource mobilization; policy formulations; creation and management of research partnerships and collaborations; management of intellectual property rights; student mentoring and innovation management. They have created the required impetus for a research and innovation culture at KCA University.

Question 3:

How does the Division of Research, Innovation and Outreach link to the university fraternity?

Answer:

The Division of Research, Innovation and Outreach offers research and innovation related support to KCA University researchers, postgraduate students and other stakeholders on a regular basis. We link to our stakeholders (internal and external) in a complementary manner through our specialized Directorates, Units and an interactive website. The directorates and units supplement the activities of other Divisions (Academic and Student Affairs; Finance, Planning and Development) to ensure realization of the university objectives and key strategic pillars. Question 4:

Managing research grants requires attention to demands of different research funders; how has the Division ensured this?

Answer:

The Division has put in place clear guidelines to ensure research grants are used and managed as per the contractual agreement between the researcher, the funder and the university. It is the position of the university that research grants must be administered in a manner that ensures the realization of the research objectives and to the satisfaction of the funder. Our experience indicates that prudent management of research grants builds trust and results in repeat awards.

Question 5:

Current trends in research demand multidisciplinary approaches. How is the Division supporting researchers on this?

Answer:

The University notes that a multidisciplinary approach to research is beneficial in providing different unique approaches and perspectives in solving societal problems; encourages teamwork among researchers from different departments/ institutions; technology transfer and yields high impact research. The university has put in place measures to support researchers to collaborate with their peers from other departments/other institutions locally and abroad. Our collaboration process goes through thorough due diligence and background check to ensure that our reputation as a premier research university of choice is protected.

Question 6:

What plans does the university have to drive or catalyze innovation and incubation?

Answer:

KCA University has a vibrant Directorate of Innovation, Incubation and University-Industry Linkages that admits innovators from both KCA University and from outside KCA University. We do this in the spirit of leaving no one behind. In addition, we remain keen and committed to collaborating with the industry in solving some of the present-day challenges as we make future projections. This partnership has supported innovators and given the industry partners the confidence to continue supporting new and viable ideas.

About the Division of Research, Innovation and Outreach KCA University

KCA University Research, Innovation and Outreach (RIO) is a new division started in 2021 to catalyze and strengthen research, innovation, and outreach ecosystem that promotes research culture among KCA University scholars and students. Headed by a Deputy Vice Chancellor, RIO is a home of distinguished and budding scholars in various fields.

RIO hosts four directorates; Directorate of Innovation, Incubation and Enterprise Development, the Directorate of Research Support and Dissemination (RSD) and Directorate of Partnerships and Collaborations, and Ethics Review Committee.

The Directorate of Innovation, Incubation and Enterprise Development (IIED) is mandated to stimulate innovation among our students, staff and the public resulting into commercialization of viable ideas and creation of employment opportunities. IIED creates a robust innovation ecosystem that enhances the innovation potential of the KCA community.

Research Support and Dissemination(RSD) directorate supports the KCA University, staff and students to excel in their research ventures. We provide an end-to-end research support system which supplements the intrinsic talents of our research community and frees them to focus on core areas of their research endeavors. Deepening of technical capacity is absolutely necessary. On this, we have a calendar of training and development events for the entire academic year which address various aspects of research needs. Pennsylvania, US

KCA University was selected by the Carnegie African Diaspora Fellowship Program (CADFP) to host an African Diaspora scholar from Pennsylvania- United States of America to work on a collaborative project aimed at growing research capacity and output as well as mentor graduate students. The Carnegie scholar was jointly hosted between KCA University and St. Paul's University in Limuru.

Prof. John Okpara from Bloomsburg University Pennsylvania, US was this year's Carnegie scholar attached to KCAU and SPU. The visit by Prof. Okpara was aimed at cross pollination of skills to ensure strengthening of research capacity as well as mentorship and supervision of postgraduate students.

With the guidance of Prof. Okpara grand proposals were jointly written and successfully submitted by KCA and St. Paul's universities.

The Carnegie African Diaspora Fellowship Program pairs African Diaspora scholars with higher education institutions and collaborators in Africa to work together on a number of areas including but not limited to curriculum co-creation, co-development, collaborative research, graduate training and mentoring activities with the aim of developing sustainable partnerships.

The CADFP, now in its tenth year, develops long-term, mutually-beneficial collaborations between universities in Africa and the United States and Canada. It is funded by Carnegie Corporation of New York and managed by the Institute of International Education (IIE) in collaboration with the Association of African Universities (AAU). Nearly 600 African Diaspora Fellowships have been awarded for scholars to travel to Africa since the program's inception in 2013.

Fellowships match host universities with African-born scholars and cover the expenses for project visits of between 14 and 90 days, including transportation, a daily stipend, and the cost of obtaining visas and health insurance.

Dr. King-White gives back to her profession by serving on the Ohio Department of Education (ODE) Whole Chile Advisory Board, the ODE Trauma-Informed Schools Committee, and the Ohio School Counseling Association Board as the Chair of the Equity and Inclusion Task Force. Her broad area of research focuses on developing mental health models in systems from a trauma-informed lens. Through her research Dakota has partnered with various organizations including KCA University where they have sought and secured funding for research projects locally and internationally.

As a way of reaching out to the community we serve, Dr. Dakota donated books and other reading materials to the "Read Baby Read program," an initiative of KCA University that targets to empower and instill reading culture among young readers in Kenya. The program was launched in Kisii County and has since supported a number of young children to improve their reading culture. Kenyan university lecturers have been caught napping twice in the recent past. The first was the onset of the structural adjustment program which came with massive job cuts, and other issues. Lecturers who were fond of enjoying generous allowances found themselves in a perilous state that pushed some to sell mandazis and others in the matatu industry to survive.

The scenario was aggravated by the "Matiangi' effect which ended moonlighting among university lecturers. This coupled with the outbreak of COVID 19 exacerbated the situation. University dons were left with no choice but to be innovative and look at ways to start commercializing their research projects and generate income.

This formed the basis of discussion on "Commercialization of Research Findings" conducted by Dr. Robert Karanja, Co-Founder and Chief Innovation Officer at Villgro Africa during the first Research Excellence and Sustainable Innovation Series 2023.

According to Karanja, commercialization and innovation of research requires reliable, coordinated and predictable flow of information and technology among people, enterprises and, institutions and academia plays a critical role as the creator of innovators.

He however said the business model of academia must be informed by the innovation systems thinking to play a dual role in research, development and innovation. The discussion was attended by deans and faculty members from various schools.







TRAVEL GRANTS

J-PAL SUMMER SCHOOL: EXPERIENCES FROM MOROCCO

The J-Pal Summer School is an annual multi-day training event that is organized by the Abdul Latif Jameel Poverty Action Lab (J-PAL) as part of the "Development Methodologies" Professorship held by Abhijit Banerjee and Esther Duflo at the Paris School of Economics. It is noteworthy that Abhijit Banerjee and Esther Duflo are professors at the Massachusetts Institute of Technology, Co-founders of the Abdul Latif Jameel Poverty Action Lab, and winners of the 2019 Nobel Prize in Economics.

The main purpose of the Summer School is to help African researchers and project leaders in getting grounded on evaluation methodologies for development interventions. The 2023 Summer School took place from July 4 to 7, 2023 in Rabat on the campus of Mohammed VI Polytechnic University. It was organized by the Abdul Latif Jameel Poverty Action Lab in partnership with the French Development Agency, the Fund for Innovation in Development, the Morocco Employment Lab, the Paris School of Economics, and the Mohammed VI Polytechnic University.

Sometime in March 2023, as I was reading the open opportunities for research funding that are always shared by our Department of Research Support on Monday, I saw a particular call from J-PAL for proposals to attend a fully funded

Summer School in Rabat, Morocco. This greatly stoked my interest because proposals that incorporate impact evaluation methodologies are currently heavily demanded by agencies that fund development research. The call required applicants to submit their application together with a proposal to undertake an impact evaluation in any area of the social sciences. I put together my application package, submitted it using the prescribed process, and kept my fingers crossed.

I was pleasantly surprised to receive an email from a J-PAL administrator notifying me that my proposal had a good scientific value and thus I had been selected to attend the Summer School, out of over 450 other applicants.

At the summer school, we had 56 participants from over 20 Sub Saharan Africa countries. We covered content on survey design and measurement, statistical power and sample size, threats to validity, ethics and research transparency, and advanced randomization designs.

We had the opportunity to learn from renowned researchers in the J-PAL network - including Esther Duflo, Abhijit Banerjee, Prof. Karen Macours of the Paris School of Economics, and Prof. Rema Hanna of Harvard University.

I made a plenary presentation on my proposal, which was on testing the impact of weather analytics and agronomic advisories on farm level productivity amongst subsistence farmers in Kenya. I specified three treatment arms and cluster-level randomization. At the sidelines of the Summer School, I had a chat with officials from the Fund for Innovation in Development on funding the development of a new innovation to minimize post-harvest losses of fish in the African Great Lakes Region. This project is still in its infancy and is being worked on by myself, Prof. Vincent Onywera, and colleagues from other Universities in Kenya, Burundi and Democratic Republic of Congo.

This Summer School helped me create a vast network with African researchers from several countries, key of which are: Nigeria, Ghana, Togo, Mali, Senegal, Ethiopia, South Africa, Malawi, and Tanzania. We are constantly in touch with each other and are always exchanging research ideas and open calls. Additionally, it helped me to meet accomplished scholars who were, and still are, ready to mentor and guide me as I build my research career.

I would like to encourage my KCA University colleagues to keep on applying to the research calls that are shared by the RIO Division. One day, you will get a breakthrough - and the rest will be history. Failing to succeed is impossible for someone who doesn't give up.



KCAU DON ATTENDS IEEE ICE CONFERENCE IN EDINBURGH

The International Conference on Engineering (ICE) is a high-impact peer-reviewed conference with an average acceptance rate of 23 percent. The conference brings international researchers together each year to present and discuss topics related to computing and engineering under the umbrella of the Institute of Electrical and Electronics Engineers (IEEE).

The IEEE ICE 2023 conference was held at the King's Buildings Campus, University of Edinburgh in Scotland, UK in June this year under the theme "Shaping the Future." The conference was attended by more than 200 researchers with most participants coming from Europe. Four attendees were from Africa: three from South Africa and one (myself) from Kenya. The conference also received participation from China, Japan, Indonesia, USA, Australia and the United Arab Emirates.

This was a three-day conference with each day running three parallel sessions and two plenaries for keynote speeches. Topics ranged from computer science, engineering, renewable energy, robotics, Al and many others. Most participants presented research outcomes, while others showcased their project outputs and ongoing collaboration activities.

The paper that I presented was co-authored with one of my master students (George Kangéthe) who is now a graduate working in Norway. The main objective of the study was to establish a model for evaluating efficacy of eLearning in higher educational institutions using secondary data. This objective was driven by the sustainable development goal No.4 of promoting inclusive learning to mitigate disruptions in the learning process. To measure the efficacy of eLearning, the study observed student activity on a learning management system against academic performance.

The study further compared the performance of different machine learning techniques, i.e., Support Vector Machine, Random Forest, Decision Tree, Nave Bayes, Logistic Regression, and Neural Network. The categorization of the six techniques established differences in levels of accuracy, precision, recall, and Fscore. The best performing machine learning algorithm formed the basis for evaluating the student performance on eLearning systems and advising educational interventions.

This paper will be soon published with the Institute of Electrical and Electronics Engineers (IEEE) Xplore as proceedings of the IEEE International Conference on Engineering, Technology, and Innovation (ICE/ITMC). All conference papers that are included in IEEE Xplore are indexed in the SCOPUS database.

The main impact of the IEEE ICE conference to me is that it has fostered my professional growth. By publishing the paper, I will contribute to the literature on elearning efficacy. The in-person attendance also allowed me to follow the proceedings throughout and gain a lot of knowledge about what others are doing, and to actively discuss with the researchers.

The keynote speeches by distinguished professors on the large projects they were undertaking offered a challenge on what more needs to be done in Kenya and other developing countries. Among the most inspiring keynotes was the one by Jarmo Eskelinen the Executive Director of Data-Driven Innovation (DDI) Programme at the University of Edinburgh. He explored the diversities in strategy between innovation ecosystems of three global powerhouses: The U.S.A conquering approach, China's emphasis on control, and Europe's penchant for collaboration. Jarmo concluded that collaboration might be the most sustainable and universally beneficial future route for startups, established firms, universities, and government bodies.

During the IEEE ICE 2023 I was able to establish networks for future research and collaboration activities. Generally, attending international conferences is inspiring and motivates researchers to explore new ideas and work with renewed energy.

I appreciate the support of Kenya Education Network (KENET) through the travel grant that catered for my travel and conference registration fees. I also thanks KCA University for granting me leave to attend the conference and covering my additional

expenses.



COPYEK PROJECT ACTIVE AND PARTICIPATORY LEARNING WORKSHOP HELD IN KENYA

Africa is projected to have the largest young workforce in the World by 2040. It will become increasingly difficult to meet the growing employment demands through traditional education, skills training, and job opportunities, highlighting the need for developing an entrepreneurship ecosystem for young people to emerge as not only job seekers but also as job creators.

The Kenyan government's Vision 2030 calls out for competitive education, research, and innovation for youth-driven economic growth. However, the knowledge of practice has been developed mostly for youth rather than with youth. The University of Nottingham, KCA University and Kenya's Youth Enterprise Development Fund (YEDF) (referred to as "the network"), under the British Council's Innovation for Africa Universities Programme, partnered in 2021-2023 to co-develop creative, participatory understanding of lived experiences of young entrepreneurs in Kenya and co-create knowledge curation and entrepreneurs' development opportunities through networks in Kenya and the UK, through the project titled "Co-Production for Youth Entrepreneurship in Kenya" (COPYEK). The project was carried out in three phases;

- a) Phase I which sought to understanding the lived experiences of young entrepreneurs and the gaps identify gaps in current entrepreneurship training programs offered by Higher Education Institutions in Kenya,
- b) phase II that considered the findings of phase I to reimagine entrepreneurship learning curricula offered at KCA University and YEDF.
- c) phase III which involved rolling out interventions to bridge the gap between entrepreneurial learning and practice.

As part of the COPYEK project intervention, the project team held a workshop in Naivasha, Kenya on the Active and Participatory Teaching and Learning Methodologies between 10-12th May 2023. The main objective of the workshop was to enhance the capacity and capability of KCA University members of academic staff to apply active and participatory teaching and learning methodologies with an aim of bridging the gap between learning and practice.

The workshop, which had 32 participants, was facilitated by Prof. Judy Muthuri, Dr. José Francisco González of University of Nottingham Business School, Dr. Tom Morton Open University Business School, Prof. Renson Muchiri, and Prof. Simon Ngigi both from KCA University, Kenya.

KCA UNIVERSITY PILOTS CHALLENGE BASED LEARNING

KCA University experimented Challenge-Based Learning (CBL) over for over two years as it became evident that, without a practical context, graduates were failing to meet the industry expectations upon getting employed.

Challenge Based Learning (CBL) model provides an effective framework for learning while solving real-world challenges. The framework promotes collaboration in identifying big ideas, asking thoughtful questions, and solving learning challenges. The model also helps learners gain deep subject area knowledge and develop the skills necessary to succeed in an ever-changing world.

CBL differs and deviates very much from the traditional test papers and multiple-choice examinations. It allows students to provide solutions based on the courses they are pursuing. The piloting was done with the MSc. Data Analytics class under the patronage of Prof. Patrick Ogao.

The university also involved external stakeholders such as K-Unity, a Sacco that acts as a means of facilitating savings and credit facilities for Dairy & Pyrethrum societies within Kiambu County. K- Unity Sacco currently has an asset base of over 6 billion with over 10000 members, and Makueni County Government health departments that provided real problems to be solved as part of the project.

The participants were presented with challenges that required them to draw on prior learning, acquire new knowledge, work as a team, and use their creativity to arrive at solutions. Speaking during the dissemination forum for CBL findings, Deputy Vice Chancellor Academic Affairs Prof. Joshua Bagaka's said the university was redefining assessments and will continue to use the model as a means of exams assessment.

"The exam questions will be tied to the course content and will require critical thinking. Exam cheating is here with us and we have evidence of cartels. If we have the programme, each learner will be addressing these challenges differently," he said. "This is a long-term process that will require critical self-reflection by teachers with a conversation centred on students' learning environment presently fostered," he said.

Bagaka's said some of the perpetrators and beneficiaries of cheating are daring and do not allow anything to stand in their way. He added that the university will always embrace technology that will assist in returning integrity and credibility of its products. Bagaka's also called for a review of universities' grading policy. The current set up requires students sit continuous assessment tests for 30 marks while the end of semester exams account for 70 marks.

"It is time to move away from the setup and give lecturers the power to vary how they weigh their learners. The final exams can even have 20 to 30 percent marks," he said.

DVC Research Innovation and Outreach Prof. Vincent Onywera said KCA University is the first institution in the country to adopt the CBL.

PANEL DISCUSSION- BLOCKCHAIN AND SUSTAINABLE DEVELOPMENT

The School of Technology held a panel discussion on "Blockchain Technologies and Sustainable Development" to mark the closure of Kenya Norway Mobility (KENOMO) program.

The discussion was jointly hosted by KCA University and the Kenya Norway Mobility (KeNoMo) project which is an academic collaboration that established a long-term sustainable relationship between KCA University, University of Stavanger (UiS) Norway, and University of Nairobi (UoN).

The] panel was composed of distinguished professors and world renown researchers who unpacked and explored the various opportunities blockchain offers in higher education.

The panelists included Prof. Rong Chunming, Head of DSComputing at University of Stavanger, Prof. Hans-Arno Jacobsen – Middleware Systems Research Group at University of Toronto in Canada, Prof. Bitange Ndemo,

Kenya's Ambassador to Belgium & EU who joined virtually, and Dr. Z. Zhao, Senior Researcher from university of Amsterdam in the Netherlands. The event was also attended by Deputy Head of Norwegian Mission Geir Arne and Dr. Sawanga Ndakala, Director State Department of University Education and Research who represented the permanent Secretary Ministry of Higher Education Dr. Beatrice Inyagala

The project funded by Norwegian Partnership Programme for Global Academic Cooperation (NORPART) was initiated in 2015 to facilitate mutual student mobility and academic cooperation between the partners to enhance the quality of computer science education in both Norway and Kenya.

By 2022, Sixteen KCAU masters students and eleven UoN masters students had traveled to the University of Stavanger for studies. Two KCAU PhD students and Four UoN PhD Students had traveled to the University of Stavanger for 3 months' research stay. Five KCAU faculty members and three UoN faculty members participated in at least one summer school that involved presentation of scientific research. There were also at least three joint workshops held for students and faculty members to exchange knowledge.

KCA UNIVERSITY TO ESTABLISH WORLD CLASS CREATIVE ARTS CENTRE

KCA University is in the process of establishing a global creative arts centre to match and feed the budding creative economy in the country and across the borders.

The arts centre will bring together industry practitioners in the university and also the scholars and students in collaborative projects of the industry.

Vice Chancellor Prof. Isaiah I.C. Wakindiki said the university will work together with the government in supporting the Talanta Hela initiative by providing short courses in business and financial skills to the creative industry.

He also said he wants to see KCAU become the benchmark of creative arts education in the East African region. KCA University offers creative arts related courses both at diploma and degree level and currently has over 1000 students.

The VC spoke when KCA University hosted Hon. Ababu Namwamba, Cabinet Secretary for Youth Affairs, the Arts and Sports for a panel discussion on "Creative Economy as an exciting frontier for national development."

Ababu challenged Kenyans to change their negative opinion towards the contribution creative sector, adding that economies such as Nigeria, South Africa, UK and America have succeeded through mainstreaming the creative sector.

He said the government was moving towards mainstreaming the creative sector through the launch of Talanta Hela initiative which will turn talents into real money. Chief Executive Officer of Kenya Film Commission Mr. Timothy Owase said the commission was already partnering with the university in capacity building and it will work with it to establish a film hub under its Studio Mashinani initiative at the creative arts centre once complete.

Other distinguished panelists included; Wanjiku Njuguna (CEO of Heva Fund), Nancy Matimu (Fintech Innovation Director & Business Lead, and the vice chairperson of the KCA University Council) and Eddie Butita (CEO of Stage Presence Media Africa).

GOVERNMENT URGED TO TAP INTO THE INFORMAL SECTOR TO INCREASE TAX COLLECTION

The Kenyan National Tax Policy provides the framework within which tax related laws, regulations and rules are formulated and



implemented. In realization of the need to rebuild the economy and the demands of the changing business environment the tax policy has become a necessary tool. Unique challenges such as expanding the taxation to the hard-to-tax sectors (agriculture and informal sector), increased online businesses and globalization requires a framework to guide the process.

The panel discussion on "Taxation and Bottom-Up Economic Model" organized by Kenya University's Centre of Excellence in Tax Education, provided broader perspectives of taxation in Kenya; existing legal and regulatory framework, challenges and policy guidelines. It also articulated the principles governing tax administration and revenue collection in Kenya. The discussants further provided guidelines for tax legislation, review, development and tax administration.

Kwame Owino, Chief Executive Institute of Economic Affairs (IEAK), Prof Vincent Ongore, Associate Professor, Business Administration & Entrepreneurship (DBAE) and Tony Murega, Accountant and Lecturer in Economics and Consultant on Micro and Small Medium Enterprises (MSMES) were the discussants during the panel discussion.

They urged the government to widen its tax base from the usual income tax through Pay As You Earn (PAYE).

An economist and former employer with KRA, Prof Ongore blamed the taxman for inefficiency in tax administration systems despite having the best technology in the continent ahead of South Africa.

"KRA has the power to collect more taxes but they have not told Kenyans the reasons they need to pay the taxes, if Kenyans see the value of paying taxes, they will pay without even being forced," he said.

INNOVATIONS

INNOVATION CENTRE CONDUCTS TECHFEST

KCA University research division in partnership with Moringa school conducted a Hackathon for students in software development in February 2023.

Students presented a total of 10 different projects in a bid to provide solutions in different areas of SDGs. The winning project received an award of Ksh 10000 while first runners up and second runners up got 7000 and 5000 respectively.

The winner developed a prototype sensor for shoes meant for visually impaired persons dubbed Uwezo shoes. The sensors help the blind detect and navigate areas with objects around them.

First runners up developed a virtual school where students were able to learn in a 3D virtual environment.

While the second runners up developed a mobile service where people can order and book "mama fua" services.

The rest of the projects were referred to our Incubation and innovation centre for further incubation.

Hackathons are forums that challenge students to analyze problems and come up with digital solutions for the betterment of our present-day society. Hackathons also play an important role in building the future of the students as they develop essential

programming skills during the event.











KIPI TRAINS KCAU STUDENTS ON INTELLECTUAL PROPERTY

Kenya Intellectual Property Institute (KIPI) conducted a training for KCA University students out on 28th September 2023. The training equipped the students with skills and Knowledge on how to protect their Intellectual Property.
